ACTIVITY REPORT:

The monthly activity report and individual program reports were approved for August 2024.

NEW BUSINESS

Drive Through Flu Clinic:

Mrs. Walker informed the board of the drive-through flu and COVID vaccine clinic, which will take place on October 10 from 9-2pm.

Accreditation Progress

Mrs. Walker gave the board an update on the progress towards accreditation. She reports that she anticipates finishing document submission by the end of October 31, 2024. She hopes to attend the site visit of the Jackson County Health Department to prepare for the CCHC site visit. She also states that the work CCHC is doing towards this endeavor was mentioned amongst state staff on multiple occasions during the state LPHA meeting last week in Columbia.

CD Purchase

Mrs. Walker reported that the CD rate discussed last month at Southern Bank was no longer available, and she requests that the board authorize her to purchase a 50,000 CD and Bank of Grandin for the rate of 5% for 3 years. Mrs. Turley made the motion, and Mrs. Murphy seconded; motion carried.

Online Portal

Mrs. Walker informed the board that the online portal is now live and that appointments can be made online.

Fall Festival

Mrs. Walker updated the board on the activities at the fall festival. CCHC will be providing shuttling service throughout the day as well as serving as the First Aid Station at the riverfront park.

After review and discussion, the next scheduled board meeting will take place on Monday, October 28 at 1:00 PM. Mrs. Murphy made a motion to adjourn the meeting, seconded by Mrs. Turley, motion carried.

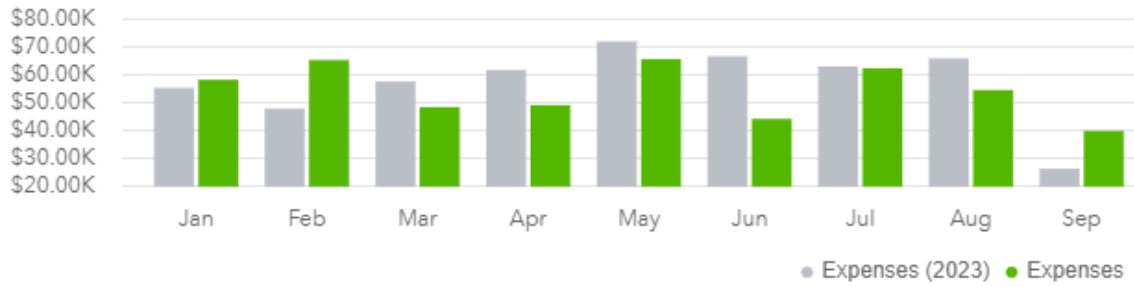

\$487,399.67

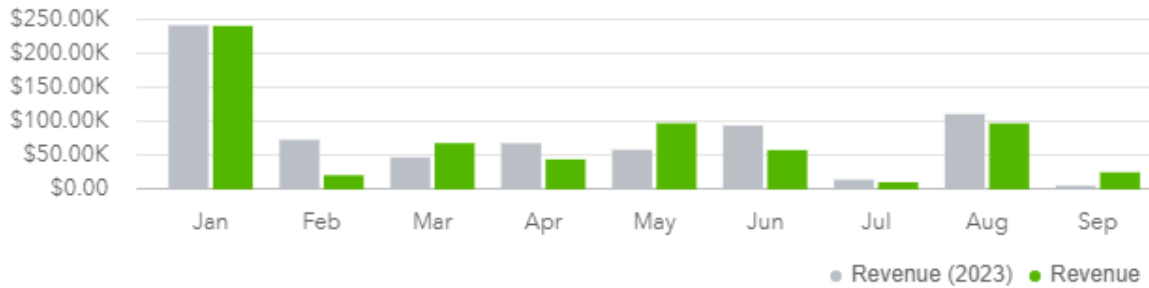


REVENUE BY TIME

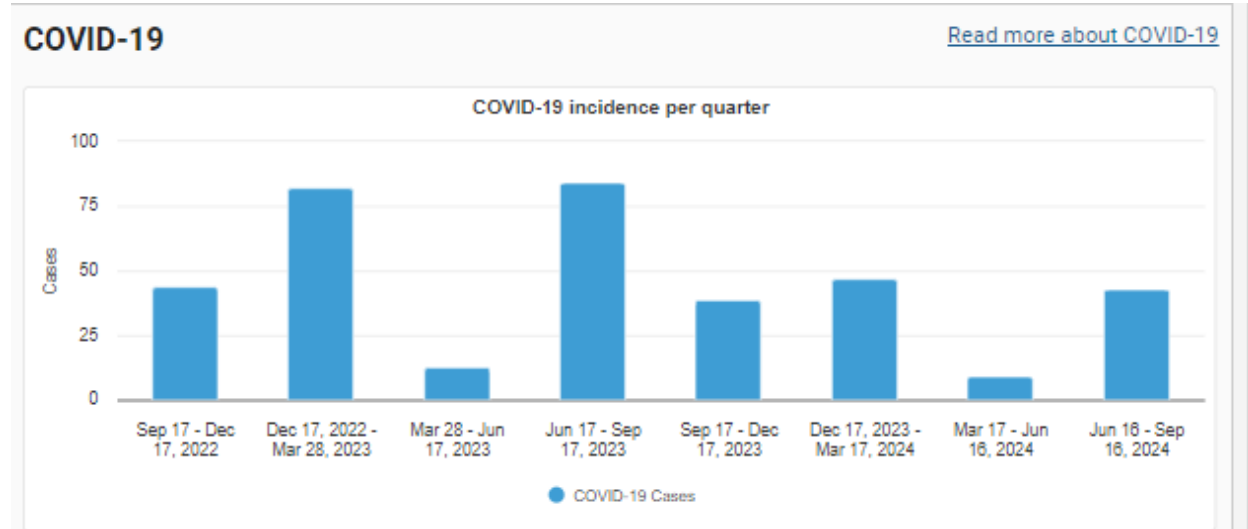
Reported Covid cases in August 2024

Other programs linked to WIC include:

- **Car seat program**- Available to Carter County residents. Convertible car seats and High Back booster seats are what we have available (limited supply) for Carter Co. residents. We have a question added to our participant encounter form that asks “*Do you have a Car Seat? Y or N*” if marked no, we ask if they are in need of a carseat.
 - 2 car seats given
- **Safe sleep**- Available to qualifying WIC participants. We have a question added to our participant encounter form “*Do you have a safe place for your baby to sleep? Y or N*” If marked “no” we offer the safe sleep questionnaire. The form is then submitted to the state agency and they determine whether the participant qualifies for a Pack N Play. If a participant qualifies the SA will mail a Pack N Play to CCHC and can be picked up by the participant.
 - non
- **Diaper Bank of the Ozarks**-Two packages of diapers are available to each child per household. For WIC clients and Carter Co. residents.
 - 7 packs of diapers given
